Happy New Year! 2025 has kicked off with some of the coolest temps we've experienced in the last few years. It may be cold now, but in August we'll no doubt be wishing for sweater-weather. That's life in Northeast Florida!

We held our Annual Meeting on Wednesday of this week, so here is a brief recap.

John Lohr summarized the year, which included thanks to the Villages for putting up with the tree removal and storm drain work, and acknowledgment of the volunteers who did the messy (and smelly) work of cleaning up the fish kill. This was indeed a testament to the gracious and helpful neighbors we all share.

Jeff Schlueter gave a Treasurer's report, showing that even with the dip into the Village Reserve Fund to cover the storm drain project, the financial condition of the HOA is on good footing.

We got updates from the Lake Committee and the Architecture Review Committees for Estates and Villages. There is a new contractor for lake maintenance that we expect will do a much better job keeping the lakes clean and healthy, and both ARCs supported residents with projects on their properties. We want to remind everyone that our ARCs defy the modern stereotype: they are here to HELP you with your projects, not deny them. The primary topic of New Business was a discussion of IQ Fiber and their service. IQF finished laying their cable along the Estates roads over the holiday; they were able to do this since those are County roads and have a public easement. We are working with IQF now to finalize the contract allowing them into the Villages and Marsh View.
